### S.A.V.E. Kids Program

Home-like visiting rooms and activities for quality parent child meetings.

Parent or Guardian receives a thorough orientation of facility & visitation policies.

Trained staff monitor every visit.

Available weekdays and weekends

Each party pays an initial processing fee & deposit.

After four visits, requests can be considered for utilization of the center's playground.

Visitations are based on a sliding scale.

Supervised Exchanges are available and may be scheduled pending staff availability

Trained staff monitor and record every visit

Available weekends, afternoons and evenings to accommodate working parents

Parents will learn to deal with each other respectfully and increase cooperation
